Have or know a college bound high school senior? Have them apply for our Scholarship! Last year Leatherstocking Credit Union awarded \$10,000 to 21 students.

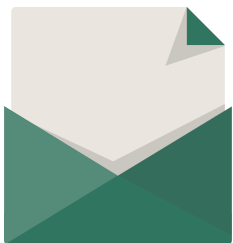

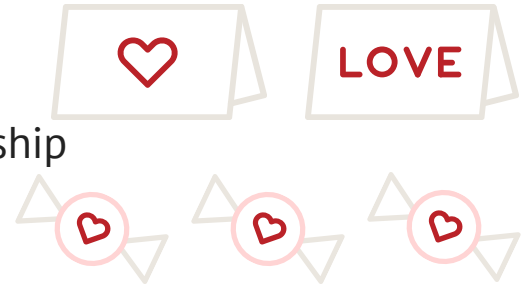

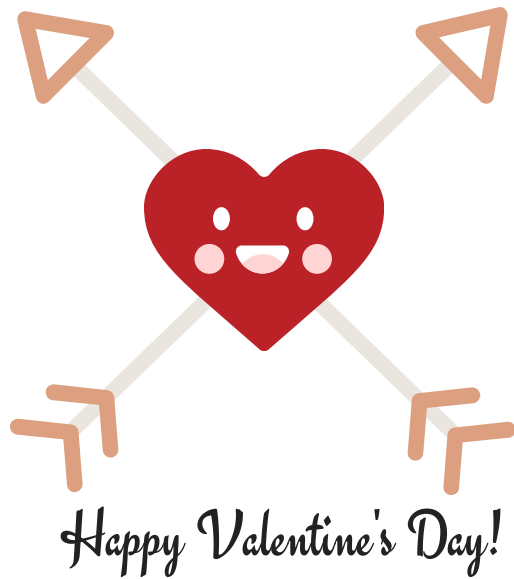
